Our school of <75 students in in a county that does not meet the metrics for reopening. Since we are in Umatilla County we will be starting the school year using the Comprehensive Distance Learning model.

We will return to on-site learning when Umatilla County has <30 cases of COVID-19 per 100,000 population in the preceding 7 days for the past three weeks and the test positivity in the county is <5% in the preceding 7 days for the past three weeks.

The classroom teacher will conduct a visual screen for the appearance of symptoms. All 3-8 students are a cohort.</p> <p>Screening Staff:</p> <ul style="list-style-type: none"> • Staff are required to report to the administrator when they may have been exposed to COVID-19 • Staff are required to report to the administrator when they have symptoms related to COVID-19. • Staff members are not responsible for screening other staff members for symptoms.
